F) NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU; THE PARTIES HERE TO AGREE AS FOLLOWS:

**For Every Clause assigned hereafter, we will take permission to the Second Party and the Second Party has the Right to take decision in respect to these Clauses.**

**CLAUSE 1: CO-OPERATION**

- i. Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- ii. First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry, the Second Party.
- iii. The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

**CLAUSE 2: SCOPE OF THE MOU**

- i. The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.

- v. **Guest Lectures:** Second Party to extend the necessary support to deliver guest lecturers to the students of the First Party on the technology trends and in house requirements.
- vi. **Faculty Development Programs:** Second Party to train the Faculties of First Party for imparting training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.
- vii. **Placement of Trained Students:** Second Party will actively engage to help the delivery of the training and placement of students of the First Party into OJT/ Apprenticeship /internships /jobs; and will facilitate placements as per their requirement.
- viii. Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programmed on the terms specified herein.

**CLAUSE 4: VALIDITY**

This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period S. B. ENGINEERING WORKS., the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of Training Partner or S. B. ENGINEERING WORKS, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU.

Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations. This MOU will be valid for 5 Years from the date of signing.
