






## CLAUSE 1 CO-OPERATION


**Guest Lectures:** Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends and in house requirements.


## CLAUSE 2 SCOPE OF THE MOU


**CLAUSE 4**
